AMENDMENTS TO THE BYLAWS OF CONCORD AT THE VINEYARDS CONDOMINIUM ASSOCIATION, INC.

The By-Laws of Concord at The Vineyards Condominium Association, Inc., shall be amended as shown below.

ARTICLE III BOARD OF DIRECTORS: TERM OF OFFICE

Section 1. Number The affairs of this Association shall be managed by a Board of at least three (3) directors initially appointed by the Developer five (5) directors.

Section 2. Term of Office Each director elected by the Members shall hold office for a term of one (1) year. All directors shall be elected for two (2) year staggered terms. A director's term will end at the annual election at which his successor is to be duly elected unless he sooner resigns or is removed as provided for in Section 3 below. In order to establish staggered terms, the three (3) directors who receive the highest number of votes at the annual election shall serve two (2) year terms, and the remaining two (2) directors shall be elected for only one (1) year.
