EXHIBIT A

13. Leasing of Units. All leases of units must be in writing. A unit owner may lease only his or her entire unit, and then only in accordance with this Section, after receiving the approval of the Association. The lessee must be a natural person.

13.2 Exceptions for Mortgagees. The provisions of Section 13.1 shall not apply to leases entered into by institutional mortgagees who acquire title through the mortgage whether by foreclosure or by a deed in

lieu of foreclosure.

14. TRANSFER OF OWNERSHIP OF UNITS. In order to maintain a community of congenial, financially responsible residents with the objectives of protecting the value of the units, inhibiting transiency, and facilitating the development of a stable, quiet community and peace of mind for all residents, the transfer of ownership of a unit shall be subject to the following provisions:

14.4 Exception. The provisions of 14.1, 14.2 and 14.3 are not applicable to the acquisition of title by an institutional mortgage who acquires title through the mortgage, whether by foreclosure or deed in lieu of foreclosure, nor shall the Association's approval shall be required for the subsequent resale or lease of a unit by such mortgagee of the unit so acquired, but shall apply to the acquisition of title by any other person.
